## 一. INTRODUCTION

### 引言

FXTM<sup>1</sup> is running the “Welcome Bonus Promotion” (the “Promotion”) and invites all Clients of FXTM from the Eligible Country to register. By registering and participating in the Promotion, you agree to be bound by the Terms and Conditions (the “Terms”) set out below.

FXTM 富拓<sup>1</sup> “迎新优惠活动”（以下简称“活动”）适用于由 FXTM 富拓决定的所有符合条件的国家/地区新客户（详见条款 3）。注册并参与本次活动，即表示您同意受以下条款及细则（以下简称“条款”）的约束。

## 二. INTERPRETATION OF TERMS

### 条款解释

#### 2.1 In this Program:

在本次活动中:

“**Account**” means a Client’s trading account with FXTM into which the Client deposits funds within the Promotion Period a Deposit.

“**账户**”指客户在 FXTM 富拓的交易账户，客户在活动期内将资金存入该账户。

“**Active Period**” refers to a consecutive 60 (sixty) calendar-day period within the Promotion Period, beginning on the day the Client accepts the Terms, makes a Deposit.

“**有效期**”指活动期内连续的 60 个自然日，从客户接受条款并存款之日起计算。

“**Benefit**” refers to the reward points that a client, who participates in the Promotion, is eligible to receive. This benefit will be credited in the Client’s reward points balance, as specified in these Terms

“**优惠**”指参与活动的客户有资格获得的奖励积分。此优惠将记入客户的奖励积分余额中，如本条款所述

“**Eligible Country**” means this promotion is only available for new clients in Greater China region.

“**符合条件的国家/地区**”指此促销活动仅适用于大中华区新客户。

“**Deposit**” refers to first deposit(s) from 200 USD to 500 USD made during the Promotion Period to activate the Promotion.

“**存款**”指在促销活动期间进行的 200 美元至 500 美元的首次存款以激活促销活动。

“**Minimum Number of Lots**” means the number of full Standard Lots that the Client needs to trade to receive the Benefit.

“**最小手数**”指客户需要通过交易来获得迎新优惠的完整标准手数。

“**Operative Agreements**” refers to agreements entered between the Client and FXTM governing all trading activities, including the Client Agreement, Policies, and Terms of Business, which can be found in the Website’s [Terms and Conditions](#) section and may be amended periodically.

“**执行协议**”指客户与 FXTM 富拓之间签订的所有交易活动协议，包括客户协议、政策和业务条款，可在网站的 [条款和条件](#) 部分找到，并可能被定期修订。

“**Promotion Period**” refers to the period 29<sup>th</sup> August 2025 – 30<sup>th</sup> June 2026 inclusive.

“**Standard Lot**” refers to a standardized quantity of the instrument being traded.

2.2 Any words not defined herein shall have the meaning provided in the Operative Agreement.

### 三. ELIGIBILITY CRITERIA

#### 资格标准

3.1 To participate in this Promotion, you must meet the following requirements:

要参加此活动，您必须满足以下要求：

- 1) You are a Client of FXTM, who is eligible to trade in accordance with and has agreed to the Operative Agreements;

您是 FXTM 富拓的客户，有资格根据并同意执行协议进行交易；

- 2) You maintain a live trading account with FXTM, meeting the applicable deposit and/or other requirements set by FXTM;

您在 FXTM 富拓开立真实交易账户，满足 FXTM 富拓设定的适用存款和/或其他要求；

- 3) You accept the Terms of this Promotion;

您接受此活动的条款；

- 4) You make your Deposit into your Account during the Promotion Period, in compliance with the requirements

outlined in points 2) and 3) above.

您在活动期间将存款存入您的账户，并符合上述 2) 和 3) 点中概述的要求；

- 5) This promotion is only available for new clients in Greater China region.

#### 四. TRADING TERMS

##### 交易条件

#### 4.1 To be eligible for the Benefit, you must meet the following Trading Terms:

要获得此优惠的资格，您必须满足以下交易条件：

- 1) You must make your Deposit using the promotional code; HIFXTM

您必须使用推广码进行存款：HIFXTM

- 2) This Promotion applies to all instruments that earn Tier Points in the Loyalty Program.

此活动适用于在至尊会员计划中赚取成长值的所有交易品种。

- 3) This Promotion is valid only for Advantage and Advantage Plus accounts.

此促销活动仅适用于超低点差账户和零佣金帐户。

- 4) A qualifying trade is defined as a complete round trade (opening and closing a position). Only trades where both the opening and closing times exceed 5 minutes will be counted towards the trade volume. Hedging trades will not be counted.

#### 4.2 Additional Clarifications:

- 1) The Promotion is applicable for all Account(s) per Client, irrespective of the number of trading accounts held by a client;

- 2) Transfer between accounts will not be considered deposits for the purpose of this Promotion.

- 4.3 If the Client does not meet the Minimum Number of Lots during the Active Period or the Terms of this Promotion, the Benefit will not be credited to the Client's Reward Points balance at the end of the Active Period.

如果客户在有效期内未达到最低手数或本推广活动的条款，则在有效期结束时，该优惠将不会记入客户的奖励积分余额。

## 五. SPECIFIC PROMOTION TERMS

### 详细活动条件

5.1 The Benefit is a 100% deposit match bonus; FXTM will match the value of first deposit made, up to \$500, during the Promotion Period.

该优惠是 100%存款匹配奖金:FXTM 富拓将匹配活动期间首次存款的价值，最高可达 500 美金。

5.2 To activate the Benefit, the Client must click the "Got a promo code?" button and enter the promotional code: HIFXTM when making the Deposit.

要激活优惠，客户必须点击“已有推广码？”按钮并在存款时输入推广码：HIFXTM。

5.3 The Client must trade at least 20,000 Tier Points to qualify for the maximum Benefit to be credited to a Client's Reward Points balance.

客户必须交易至少 20,000 点成长值，才有资格获得计入客户奖励积分余额的最大优惠。

5.4 These will be credited in multiples of 25,000 Reward Points. To earn the 25,000 Reward Points, you must trade at 2,000 Tier Points during the Promotion Period.

5.5 The Benefit will be credited to the Client's FXTM Rewards Points balance after the terms hereof are met during the Promotion Period.

## 6. MISCELLANEOUS

6.1 If there is any dispute or misrepresentation related to this Promotion, such dispute shall be resolved by FXTM, acting in good faith and at its sole discretion. FXTM's decision will be final and binding.

6.2 FXTM reserves the right, at its sole discretion, to disqualify any Client from participating in the Promotion and/or withdraw the Benefit and/or any associated benefits if:

1) A breach of these Terms and/or any term of the Operative Agreements occurs;

- 6.3 Any indication or suspicion of fraud, manipulation, or deceitful activities related to the Benefit will nullify all transactions executed and any profits or rewards accrued.
