The Trail Appliances E-Newsletter & SMS Subscription Contest Giveaway (the “**Contest**”) is a quarterly contest offered by Trail Appliances (“**Trail Appliances**”). The Contest will run from June 2, 2026 to September 2, 2026, and quarterly from September 3, 2026 to December 3, 2026, and December 4, 2026 to March 4, 2027 (the “**Contest Period**”) online at <https://www.trailappliances.com/> (the “**Contest Website**”).

By participating in the Contest, you acknowledge that you have read, understand and agree to be bound by these Trail Appliances E-Newsletter & SMS Subscription Contest Giveaway Promotion Rules (these “**Contest Rules**”). ELIGIBILITY

The Contest is open to all residents of British Columbia who are at least 19 years of age as of the date of entry. All directors, officers, employees, representatives and agents of Trail Appliances and its subsidiaries and affiliates or its advertising or promotional agencies, prize suppliers, or any other entity involved in the development, production, administration, or fulfillment of the Contest (the “**Trail Appliances Group**”), are ineligible to participate in the Contest.

HOW TO WIN

A random draw from all eligible Entries will take place at 12pm PST on September 3, 2026 and every 3 months occurring December 4, 2026 and March 5, 2027, at the Trail Appliances Head Office in Richmond, British Columbia. Following the draw, Trail Appliances will notify the selected entrants by either phone or email, as provided on the entrant’s entry form (the “**Notice**”). The selected entrant must respond as directed in the Notice within five (5) business days of the date on which the Notice was sent by Trail Appliances. If a selected entrant does not respond in accordance with these Contest Rules, or Trail Appliances is unable to contact the selected entrant for any reason, Trail Appliances may select another entrant from the remaining eligible Entries.

To win the applicable Prize, the selected entrant must be actively subscribed to Trail Appliances’ E-Newsletter and SMS lists and must correctly answer, without assistance of any kind, a time-limited, mathematical, skill-testing question on the entry form. The answer will be verified and must be deemed to be correct.
