AB InBev reports on the progress of its share buy-back program announced on 31 October 2024

02 June 2025 – Anheuser-Busch InBev (Euronext: ABI) (NYSE: BUD) (MEXBOL: ANB) (JSE:ANH) ("AB InBev") ("the Company") hereby discloses certain information in relation to its share buy-back program announced on 31 October 2024, in accordance with article 8:4 of the Royal Decree of 29 April 2019 implementing the Belgian Code on Companies and Associations. Under this program, AB InBev has granted a discretionary mandate to an independent financial intermediary to repurchase AB InBev shares.

Further to the launch of the share buy-back program announced on 31 October 2024, Anheuser-Busch InBev reports the purchase of 603,860 Anheuser-Busch InBev shares in the period from 26 May 2025 up to and including 30 May 2025. The shares were repurchased at an average price of 61.87719 EUR per share for a total consideration of 37,365,162.43 EUR.

Since the start of the share buy-back program on 13 November 2024, Anheuser-Busch InBev has bought back 33,206,339 shares for a total amount of 1,766,570,959.32 EUR (1,901,482,637.68 USD) under the share buy-back program. This corresponds to 1.64% of the total shares outstanding.
