## Disclosure Made According the Requirements of the Law of 2 May 2007

25 July 2025 – Anheuser-Busch InBev (Euronext: ABI) (NYSE: BUD) (MEXBOL: ANB) (JSE:ANH) ("AB InBev") ("the Company") announces today, in accordance with article 14, first paragraph of the Law of 2 May 2007, that it received five transparency notifications from BlackRock, Inc. one dated 17 July 2025, one dated 18 July 2025, one dated 21 July 2025, one dated 24 July 2025 and one dated 25 July 2025.

The percentage of total voting rights attached to shares held by BlackRock, Inc. has first crossed downwards the threshold of 3% on 16 July 2025, as a result of disposals of voting securities or voting rights in the Company. Then the percentage of voting rights attached to shares held by BlackRock, Inc. has crossed upwards the threshold of 3% on 17 July 2025, as a result of acquisitions of voting securities or voting rights in the Company. On 18 July 2025, the percentage of total voting rights attached to shares held by BlackRock, Inc. again crossed downwards the threshold of 3%, as a result of disposals of voting securities or voting rights in the Company.

Finally, on 23 July 2025 the percentage of total voting rights held by BlackRock, Inc. crossed downwards the threshold of 3% as a result of disposals of voting securities or voting rights, and on 24 July 2025, this percentage once again crossed upwards the threshold of 3%, as a result of acquisitions of voting securities or voting rights in the Company.
