15 May 2025 – Anheuser-Busch InBev (Euronext: ABI) (NYSE: BUD) (MEXBOL: ANB) (JSE:ANH) (“AB InBev”) (“the Company”) announces today, in accordance with article 14, first paragraph of the Law of 2 May 2007, that it received one transparency notification on 12 May 2025, one transparency notification on 13 May 2025 and one transparency notification on 15 May 2025, in accordance with articles 6 and 18 of the Law of 2 May 2007.

The percentage of total voting rights and voting rights attached to shares held by BlackRock, Inc. has first crossed upwards the threshold of 3% on 8 May 2025, as a result of acquisitions of voting securities or voting rights in the Company.
