# BUSCH® RACING SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER FOR A CHANCE TO WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. #### 1. **ELIGIBILITY**:

The "Busch Racing Sweepstakes" ("Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia who are twenty-one (21) years of age or older at the time of entry. ## 3. TWO (2) WAYS TO ENTER:

#### For All Entries:
