Lottery Rules of Play- 50/50 Lottery

Lottery Dates: April 3, 2024 through to March 26, 2025



This raffle is licensed by the Alcohol and Gaming Commission of Ontario and is subject to regulations set by the Alcohol and Gaming Commission of Ontario.

Trillium Health Partners Foundation may amend these rules at any time and in any manner subject to the approval of the AGCO.

This is a 50/50 lottery: 50% of gross revenue goes to the winners, 50% of gross revenue is collected by the Lottery officials and distributed to a specific Trillium initiative approved by the licensing authority.

Eligibility

- a) Entry is open to Trillium Health Partners staff and volunteers only.
- b) Persons under the age of 18 years are not eligible to enter. All participants will be advised that purchasers may not enter the name of someone under the age of 18 on the ticket.
- c) Persons must be a resident of Ontario to enter.
- d) Trillium Health Partners Foundation Staff and Trillium Health Partners Physicians as well as Trillium Health Partners Board of Directors, and Trillium Health Partners Foundation Board Members are not permitted to purchase tickets and are not eligible to win.
- e) The liability of the licensee of this lottery shall be limited to the purchase price of the ticket.

Tickets

- a) Tickets are purchased through Payroll by enrolling online at the website [Survey - Better Together 50/50 Lottery - Trillium Health Partners Foundation \(trilliumgiving.ca\)](https://trilliumgiving.ca) or through pre-paying by cheque.
- b) Purchase price of ticket is \$7.00 for 2 draws.
- c) No participant may purchase more than six tickets per draw. Individuals who have not paid through payroll deductions or by cheque by the draw date are not eligible to participate in the draw.
- d) Only one name is allowed to be entered per ticket.
- e) Participants will be accepted in order of receipt of applications. In the event of more applicants than available tickets, later applicants will be placed on a waiting list. The maximum number of tickets is 7,500 per draw.

Draws

- a) The licensee has designated three (3) bona fide members in charge. Any two present:

Bona fide members are not eligible to win.
- b) Weekly grand prize tickets are drawn at the offices of the Trillium Health Partners Foundation, Mississauga. Draws will take place every Wednesday, commencing April 3, 2024 through to March 26, 2025 at 9:00am. All tickets are placed in an official lottery drum which is spun a minimum of 3 times. At least two bona fide members in charge shall attend the draw.
- c) Lottery rules and draw dates will be posted at every lottery draw.

Prize Winner Notification

- a) All winners are notified in person, by telephone or by email and their name will be posted in the office of the Foundation. In addition, it will be posted on the Trillium Health Partners Foundation website and Trillium Communications.
- b) Prizes are paid by cheque and can be picked up at the Trillium Health Partners Foundation office or mailed.

Prize Claim

- a) Prizes will be awarded to the Purchaser named on the official ticket. By claiming a prize, the winner consents to the use of their first and last name, ticket number and to be shared in Trillium Health Partners Foundation 50/50 communications.
- b) Winners have up to six (6) months to claim their prize. If after the period of six (6) months, the prize has not been claimed, the money will remain in the trust account and donated to a similar charity which has been deemed eligible. Distribution of unclaimed prizes will require the approval of the Alcohol and Gaming Commission of Ontario before it can be distributed.

Privacy

- a) Winners contact information will be shared with the licensing authority. Contact info for all other ticket purchasers may be shared with the licensing authority.
