# THE BASIC RULES

---

## WHAT IS PERMITTED - AND WHAT IS NOT.



### **The Unicity products are supplements.**

The Unicity products are food in the best sense of the word! They provide your body with nutrients and can help you get in better shape as part of a healthy lifestyle. General good health can make a big difference!

**Please note:** Our products are not intended to prevent, treat or cure any disease. Therefore, direct or indirect claims that a Unicity product has prevented or cured a health problem are strictly prohibited.

### **Testimonials need to be first-hand.**

Tell others about your personal success stories with Unicity or use non-manipulated third-party audio and video material (with their consent). Nothing is more contagious than your honest enthusiasm. This way you can also be sure that every detail you tell is true.

**Please note:** Do not pass on statements from third parties.

### **The guidelines apply to individual products and product systems.**

Whether you want to share your experience with a product or follow a proven system that your team has developed, the rules are always the same.

**Please note:** Do not attribute any additional effect to Unicity product combinations that have not been evaluated and confirmed by Unicity.

### **The rules apply to everyone.**

Unicity's product claim guidelines are the same for all Unicity Franchise Partners. Whether you are a doctor, physiotherapist or esthetician, your education has no bearing on what claims you are allowed to make. You can mention your profession in connection with your name, but do not use it for product recommendations („As a nutritionist, I recommend...“).

**Please note:** Do not use images of medical equipment, consulting rooms or the like in connection with Unicity.

**A picture is worth a thousand words.**

That's why we love before-and-after pictures! The prerequisite is that the pictures are not edited (e.g. filters) and are taken under as identical circumstances as possible – from the position of the person photographed to the camera to the surroundings and clothing. Besides, this makes the pictures even more convincing! If you want to illustrate the business opportunity, take only authentic pictures (e.g. of your own car) and always show the current Unicity income statement alongside them.

**Please note:** Don't use imagery that indirectly conveys unauthorized statements – for example pictures of disease symptoms in connection with a product.

**The business opportunity must live up to its promise.**

Our Franchise Partners love what they do! Tell other people what excites you about your Unicity business – the mission to Make Life Better, the teamwork, or the atmosphere at events. Of course, you should also talk about the financial potential of our business opportunity. Always keep in mind that success as a Unicity Franchise Partner depends on individual effort. Claims about income must be realistic and always accompanied by the current Unicity income calculation.

**Please note:** Do not show current payments or checks received. Do not provide income guarantees or give prospects the impression that following a system will automatically lead to success. Do not quote any income amounts without quoting the current Unicity income statement.



Unicity will review your testimonials in advance. Your personal testimonials, images, etc. must be approved by Unicity prior to use. This means that you can relax and are on the safe side with your testimonials. We are happy to help!
