

**OFFICIAL RULES**  
**2024 JUSTIN EMMY® AWARDS SEASON SWEEPSTAKES**

**ENTRY INTO THE 2024 JUSTIN EMMY® AWARDS SEASON SWEEPSTAKES ("SWEEPSTAKES") CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES.**
