

**ESCAPE TO KONA GETAWAYS  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER FOR A CHANCE TO WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE SWEEPSTAKES IS OPEN ONLY TO PERSONS WHO ARE, AT THE TIME OF ENTRY, LEGAL RESIDENTS OF THE CONTINENTAL UNITED STATES (INCLUDING ALASKA AND THE DISTRICT OF COLUMBIA; EXCLUDING HAWAII), WHO ARE TWENTY-ONE (21) YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. SWEEPSTAKES WILL BE GOVERNED BY UNITED STATES LAW. VOID WHERE PROHIBITED.**

**1. ELIGIBILITY:**

The “Escape to Kona Getaways” (“Sweepstakes”) is open to legal residents of the continental United States (including Alaska and the District of Columbia; excluding Hawaii), who are twenty-one (21) years of age or older at the time of entry. Employees, contractors, directors, officers, and agents of Anheuser-Busch, LLC, its affiliates and subsidiaries, advertising and promotion agencies, wholesale distributors, retail licensees, all other service or governmental agencies and their employees involved with the Sweepstakes, and members of their immediate families (spouse, parent, child, or sibling; whether biological, adopted, step, or in-law) or households (whether related or not) are not eligible to participate. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant’s full and unconditional agreement to these Official Rules (“Official Rules”) and Sponsor’s decisions which are final and binding in all matters related to this Sweepstakes. **2. SWEEPSTAKES PERIOD:**

Sweepstakes begins at 12:00:00 a.m. Eastern Daylight Time (“EDT”) on June 1, 2024, and ends at 11:59:59 p.m. EDT on August 31, 2024 (“Sweepstakes Period”). The Sweepstakes Period is divided into six (6) entry periods (each an “Entry Period”) as defined in the chart below. Sponsor’s computer is the official time keeping device for this Sweepstakes.

**3. TWO (2) WAYS TO ENTER:**

(a) Internet: During each Entry Period, visit <https://www.konabigwave.com/konagetaway> (“Website”) and follow the online instructions to complete and submit an online entry (“Entry”) for a chance to win a second prize (“Second

Prize”). You will also receive one (1) Entry into the grand prize (“Grand Prize”) drawing and one (1) Entry into the first prize (“First Prize”) drawing. See Rule No. 4 for drawing details.

(b) QR Code: During each Entry Period, use your smart phone or other web-enabled device with data plan to scan the Sweepstakes quick response (“QR”) code featured on signs or promotional materials at participating stores with the QR read application already installed on your phone. You will be directed to a mobile Web page at <https://www.konabigwave.com/konagetaway> (also a “Website”) where you may complete and submit an entry (also an “Entry”) for a chance to win a second prize (also a “Second Prize”). For all Entries:

All drawings will be conducted by Sponsor, whose decisions are final in all matters relating to this Sweepstakes. Non-winning Entries from Entry Period 1 will carry forward to the Entry Period 2 drawing. Odds of winning depend on the number of eligible Sweepstakes Entries received during Entry Period 1. See Rule No. 6 for Second Prize details.

Entry Period 2 Drawing: Ten (10) potential winners will be selected in a random drawing to be held on or about July 1, 2024, from among all eligible Entries received by Sponsor. All drawings will be conducted by Sponsor, whose decisions are final in all matters relating to this Sweepstakes. Non-winning Entries from Entry Period 2 will carry forward to the Entry Period 3 drawing. Odds of winning depend on the number of eligible Sweepstakes Entries received during Entry Period 2. See Rule No. 6 for Second Prize details.

Entry Period 3 Drawing: Ten (10) potential winners will be selected in a random drawing to be held on or about July 16, 2024, from among all eligible Entries received by Sponsor. All drawings will be conducted by Sponsor, whose decisions are final in all matters relating to this Sweepstakes. Non-winning Entries from Entry Period 3 will carry forward to the Entry Period 4 drawing. Odds of winning depend on the number of eligible Sweepstakes Entries received during Entry Period 3. See Rule No. 6 for Second Prize details.

Entry Period 4 Drawing: Ten (10) potential winners will be selected in a random drawing to be held on or about August 1, 2024, from among all eligible Entries received by Sponsor. All drawings will be conducted by Sponsor, whose decisions are final in all matters relating to this Sweepstakes. Non-winning Entries from Entry Period 4 will carry forward to the Entry Period 5 drawing. Odds of winning depend on the number of eligible Sweepstakes Entries received during Entry Period 4. See Rule No. 6 for Second Prize details.

Entry Period 5 Drawing: Ten (10) potential winners will be selected in a random drawing to be held on or about August 16, 2024, from among all eligible Entries received by Sponsor. All drawings will be conducted by Sponsor, whose decisions are final in all matters relating to this Sweepstakes. Non-winning Entries from Entry Period 5 will carry forward to the Entry Period 6 drawing. Odds of winning depend on the number of eligible Sweepstakes Entries received during Entry Period 5. See Rule No. 6 for Second Prize details.

Entry Period 6 Drawing: Ten (10) potential winners will be selected in a random drawing to be held on or about September 3, 2024, from among all eligible Entries received by Sponsor. All drawings will be conducted by Sponsor, whose decisions are final in all matters relating to this Sweepstakes. Odds of winning depend on the number of eligible Sweepstakes Entries received during Entry Period 6. See Rule No. 6 for Second Prize details.

Grand Prize and First Prize Drawings: All non-winning Entries will be eligible for the Grand Prize and First Prize drawings. Potential Grand Prize winners and potential First Prize winners will be selected in a random drawing to be held on or about September 3, 2024, from among all eligible entries received during the Sweepstakes Period. All drawings will be conducted by Sponsor, whose decisions are final in all matters relating to this Sweepstakes. ## **5. WINNER NOTIFICATION AND OBLIGATIONS:**

All prizes will be awarded (time permitting for Grand Prize). Potential winners will be notified by email or phone call and will be required to respond to the notification within forty-eight (48) hours indicating whether he/she can accept the prize. If a potential winner does not respond to the notification within the forty-eight (48) hour time period, prize will be forfeited and an alternate potential winner will be randomly selected (time permitting for Grand Prize). Any

alternate potential winner selected will also be required to respond to the notification within the time frame stated above.
