## SURVIVOR PICK ‘EM 2022 PROMOTION OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER FOR A CHANCE TO WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE PROMOTION IS INTENDED FOR VIEWING AND PARTICIPATION ONLY BY THOSE WHO ARE AGE 21 OR OLDER AND LOCATED IN ONE OF THE FIFTY (50) UNITED STATES OR DISTRICT OF COLUMBIA. PROMOTION WILL BE GOVERNED BY UNITED STATES LAW. VOID WHERE PROHIBITED. INTERNET ACCESS IS REQUIRED TO PARTICIPATE. STANDARD MESSAGE AND DATA RATES MAY APPLY IF PARTICIPATING VIA A MOBILE DEVICE.

1. PROMOTION OVERVIEW: The general premise of the Bud Light x NFL Ultimate Fandom Survivor Pick 'Em 2022 promotion (the "Promotion") is for each Participant (as defined in Rule 2) to pick one National Football League ("NFL") team ("Team") per enrollment to win a regular season NFL football game ("Game") each Game Week (as defined in Rule 3, below) during the Promotion Play Period (as defined in Rule 3, below). If the Participant's selected Team wins its Game that Game Week the Participant earns one point ("Point") for that enrollment and qualifies to continue playing the next Game Week. If the Participant's selected Team for that enrollment does not win its Game that Game Week, the Participant is eliminated from further play in the Promotion under that enrollment.

Ticket prize winners are responsible for all costs and expenses related to travel to and from the game, and any other incidental expenses associated with attending the game.
2. ELIGIBILITY: The Promotion is open only to legal residents of the fifty (50) United States and District of Columbia who are twenty-one (21) years of age or older at the time of enrollment ("Eligible Participants"). Employees, contractors, directors, officers, and representatives of Anheuser-Busch, LLC (the "Sponsor"), NFL Enterprises LLC and the NFL Parties (defined as NFL Properties LLC, National Football League, its member professional football clubs, NFL Ventures, Inc., NFL Ventures, L.P., NFL Enterprises LLC, NFL International LLC, NFL Productions LLC) (NFL Enterprises LLC and NFL Parties and each of their respective subsidiaries, affiliates, shareholders, officers, directors, agents, representatives and employees shall be referred to herein collectively as "The NFL Entities"), Administrator, and each of the foregoing entities' respective affiliates, subsidiaries, owners, shareholders, officers, directors, agents, representatives, employees, advertising and promotion agencies, wholesale distributors, retail licensees, and all other service agencies involved with the Promotion, and members of their immediate families (spouse, parent, child or sibling; whether biological, adopted, step or in-law) or households (whether related or not) are not eligible to enter or win. The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Each Eligible Participant may enroll (pursuant to the enrollment details set forth in Rule 4, below) up to five (5) times during the Enrollment Period, regardless of entry method. Once enrolled, the Eligible Participant shall be referred to as a "Participant."

Participant irrevocably waives all claims against the NFL Entities and agrees that The NFL Entities will have no liability or responsibility for any claim arising in connection with participation in this Promotion or the prizes awarded. The NFL Entities have not offered or sponsored this Promotion in any way.

By enrolling, each Participant agrees that if they are selected as a potential winner, Sponsor may conduct a background check on such Participant using all legal means and all publicly available information, including but not limited to civil and criminal records ("Background Check"). If a prize includes tickets, or if the prize is an event where the potential winner may invite a guest, the potential winner's guest must also consent to a Background Check. Sponsor reserves the right to disqualify any potential winner and/or guest for failure to satisfactorily pass a Background Check, as determined by Sponsor in its sole discretion ("to pass"). Factors that would result in failure to pass the background check and result in disqualification as the potential prize winner or guest include, without limitation, having been convicted of a felony or misdemeanor, committing a crime of fraud or deceit, moral turpitude, being delinquent on a government ordered payment, such as child support, spousal support, alimony, tax payments, or any other information or occurrence that could bring the Sponsor into public disrepute, contempt, scandal or ridicule or reflect unfavorably on the Sponsor.
3. IMPORTANT DATES, DEFINITIONS AND TIME PERIODS: For purposes of these Official Rules, all times are Eastern Time (Eastern Daylight Time until November 6, 2022, and Eastern Standard Time thereafter).
a. Promotion Period. The overall time period for the Promotion begins at 12:00 a.m. on October 3, 2022 and ends when the final prize is awarded (the "Promotion Period").
b. Enrollment Period. Enrollment in the Promotion will begin at 12:00 a.m. on October 3, 2022 and ends at 11:59:59 p.m. on January 5, 2023 (the "Enrollment Period").
c. Promotion Play Period. The time period within the overall Promotion Period during which NFL Games are played and Participants make Weekly Picks (as defined in Rule 5) during the Selection Period, until and unless such Participant is eliminated, begins on October 11, 2022 and ends on January 8, 2023 ("Promotion Play Period").
d. Game Week. Beginning with the first Thursday during the Promotion Play Period, each five day period beginning on Thursday and ending on the following Monday shall be referred to as a "Game Week." For the avoidance of doubt, a Game Week does not coincide with a calendar week.
e. Selection Period. During each Game Week, the NFL has scheduled Games that may occur on Thursday, Saturday, Sunday, or Monday (each a "Game Day"). For each Game Week there will be a date and time when Sponsor opens up the Game Play Sites (as defined in Rule 4) to accept Participants' Team selection for the Week ("Selection Opening"); and for each Game Day during that Game Week, there will be a date and time
when Sponsor closes the Game Sites and no longer accepts Participants' Team selection for that Game Day ("Selection Lock"). The period of time from Selection Opening of the Game Week to Selection Lock of the last Game Day of that Game Week shall be referred to as the "Selection Period." The Selection Periods for each Game Week are detailed in the Tables for each Game Week at the end of Rule 3.
f. Drawings.
i. Wave One Drawings and Wave One Play Period. On or about November 15, 2022, Sponsor will conduct a series of drawings as specified in Rule 6.a. (each a "Wave One Drawing"). To be eligible for a Wave One Drawing, a Participant must have an eligible enrollment for which they made a Weekly Pick (as defined in Rule 5) during the period of October 6, 2022 through November 15, 2022 ("Wave One Play Period"), and for which they earned at least one (1) Point associated with that enrollment in the Wave One Play Period.
ii. Wave Two Drawings. On or about December 13, 2022, Sponsor will conduct a series of drawings (each a "Wave Two Drawing"). To be eligible for a Wave Two Drawing, a Participant must have an eligible enrollment for which they made a Weekly Pick during the period of November 15, 2022 through December 13, 2022 ("Wave Two Play Period"), and for which they earned at least one (1) Point associated with that enrollment in the Wave Two Play Period.
iii. Wave Three Drawings. On or about January 10, 2023, Sponsor will conduct a series of drawings (each a "Wave Three Drawing"). To be eligible for a Wave Three Drawing, a Participant must have an eligible enrollment for which they made a Weekly Pick during the period of December 13, 2022 through January 10, 2022 ("Wave Three Play Period"), and for which they earned at least one (1) Point associated with that enrollment in the Wave Three Play Period.
iv. Grand Prize Drawing. On or about January 10, 2023, Sponsor will conduct two Grand Prize Drawings. To be eligible for the Grand Prize Drawings, a Participant must have an eligible enrollment for which they received a thirteen Point Streak during the Promotional Play Period. If no Participants achieved a thirteen Point Streak during the Promotion Play Period, eligibility for the Grand Prize Drawing will open up to Participants who have an eligible enrollment for which they received a twelve Point Streak during the Promotion Play Period. If no Participants achieved a twelve Point Streak during the Promotional Play Period, eligibility for the Grand Prize Drawing will continue to decrease by one Point Streak until there is at least one Participant with an enrollment eligible for the Grand Prize Drawing.

## 4. HOW TO ENROLL:

a. Enrollment with NFT Purchase: During the Enrollment Period, Eligible Participants will be automatically enrolled in the Promotion when they purchase a Bud Light x NFL Ultimate Fandom NFT featuring one of the 32 NFL teams (each a "Bud Light NFT") at www.fandom.budlight.com (the "Promotion NFT Site"). To participate in the Promotion using a Bud Light NFT, you must purchase the Bud Light NFT using a credit card, and you must have a Dapper wallet in which to keep it. If you do not already have a Dapper wallet, you must create a Dapper wallet on the Promotion NFT Site. You may purchase multiple Bud Light NFTs for multiple enrollments in the Promotion, up to a maximum of five enrollments in the Promotion. Once you have five enrollments in the Promotion (whether such enrollments are through Bud Light NFT purchases or Email Enrollment Requests), any additional purchases of Bud Light NFTs will not result in additional enrollments in the Promotion.
b. Enrollment without Purchase: During the Enrollment Period, Eligible Participants may enroll in the Promotion without purchasing a Bud Light NFT by sending an email (from their own personal email address that is not shared with another party and which must be an email address they can use for all communication in connection with the Promotion throughout the Promotion Period) to budlightxnflsurvivorpickemgame2022@game.budlightpickem.com with the Eligible Participant's first and last name, street address (including street number and name, city, state and zip code), and date of birth ("Email Enrollment Request"). Upon receipt of a valid Email Enrollment Request, Administrator will send the Eligible Participant making the request a reply email ("Reply Email") with a link to the Official Rules and the Bud Light Privacy Policy ("Rules and Policy"), which the Eligible Participant must review and agree to as directed in the Reply Email. Upon receipt of such acknowledgment, as specified in the Reply Email, Administrator will send the Participant a link and access credentials to an alternative entry Promotion game play site ("Alternative Site").

The Promotion NFT Site and the Alternative Site may each be referred to interchangeably in these rules as a "Game Play Site" and collectively as the "Game Play Sites."
c. Regardless of enrollment method, once enrolled, an Eligible Participant becomes a "Participant" for purposes of the Official Rules. Enrollment in the Promotion alone does not result in eligibility for any drawing or prize. Successful enrollment merely allows the Participant to access a Game Play Site in order to make Weekly Picks in the Promotion
under that enrollment until eliminated, or until the Promotion Play Period ends, whichever occurs first.
d. Limit five (5) enrollments per Eligible Participant, and per email address or IP address, during the entire Enrollment Period, regardless of enrollment method. Any attempt to use "bots," software, equipment, or other means to increase the number of enrollments per Eligible Participant may result in disqualification of some or all such enrollments from this Promotion, as well as eligibility for future promotions sponsored by Sponsor, in Sponsor's sole discretion.

## 5. HOW TO PLAY:

a. When to Make First Selection. Once enrolled, Participants may make their first Team selection during the next open Selection Period, as indicated by the applicable Table in Rule 3. Once the first Weekly pick is made for a particular enrollment, the Participant must continue to make a Weekly Pick each week during the Selection Period or that enrollment will be eliminated.
b. Where to Make Selections. To make a Team selection, Participants must visit the Game Play Site associated with that enrollment and follow the on-screen directions to:
i. Select the enrollment for which they want to make a Team selection (if they have more than one enrollment), and
ii. Select one Team they predict will win their Game that Game Week (their "Weekly Pick").
iii. Selections must be "Locked in" by the Selection Lock date specified for that Team based on its Game Day that Game Week.
c. Note that for each enrollment, Participants may only pick a Team one time during the entire Promotion Play Period. To be clear, once a Participant picks a Team to win a Game, they may not pick that Team again (unless they are picking the Team in connection with a different enrollment).
d. Earning Points and Accumulating Point Streaks.
i. If the Participant's Weekly Pick for an enrollment is correct (i.e., the Team wins its Game), the Participant will earn one (1) Point for that enrollment, and will be eligible to continue playing under that enrollment in the Promotion during the next Game Week.
ii. If for any reason the Team a Participant selected does not play in a Game that Week (e.g., cancellation or postponement for any reason including but not limited to weather, public emergency, team illness, etc.), and there was still time before the Selection Period closed for that Week in which the Participant could make a new Weekly Pick for a Team playing in a different Game that Week, the Participant must
make a new Weekly Pick for that Week prior to the end of the Selection Period in order to avoid elimination for failure to participate that Week. If the Team does not play in a Game that Week and the announcement is made after the Selection Period has ended for all remaining Games that Week for which the Participant could pick a Team, then the Participant's originally selected Team for that Week will be treated as having won its Game, the Participant will earn one (1) Point for that enrollment, and the Participant will be eligible to continuing playing under that enrollment in the Promotion during the next Game Week.
iii. Each Game Week that the Participant remains in the Promotion under that same enrollment and earns a Point, that Point will be added to previously earned Points under that enrollment, the total of which will be the Participant's "Point Streak."
e. Elimination.
i. If the Participant's Weekly Pick is not correct (i.e., the Team either loses their Game or the Game results in a tie), the Participant will not earn a Point and the Participant will be eliminated from making further selections in the Promotion under that enrollment.
ii. Once a Participant earns their first Point under an enrollment, if the Participant fails to Lock a Team in during a subsequent Selection Period when they are otherwise still eligible under that enrollment, that Participant will be eliminated under that enrollment. In other words, you must play each week you are eligible to maintain your eligibility.
iii. Once a Participant is eliminated under a particular enrollment, that Participant will end the Promotion with their current Point Streak and will enter the next series of Wave Drawings (as detailed in Rule 6).

## 6. WAVE DRAWINGS AND GRAND PRIZE DRAWING:

a. Wave One Drawings. On or about November 15, 2022, a total of 11,800 potential winners will be selected at random from among all eligible entries received, with the specific number of winners for each respective Point Streak Drawing within the series of Wave One Drawings as specified in the Wave One Prize Table in Rule 7.a., below. Odds of winning depend upon the number of eligible entries received for each drawing.
i. The Wave One Drawings include the following Drawings:
(a) Wave One 1 Point Streak Drawing for the Wave One 1 Point Streak Prize
(b) Wave One 2 Point Streak Drawing for the Wave One 2 Point Streak Prize
(c) Wave One 3 Point Streak Drawing for the Wave One 3 Point Streak Prize
(d) Wave One 4 Point Streak Drawing for the Wave One 4 Point Streak Prize
(e) Wave One 5 Point Streak Drawing for the Wave One 5 Point Streak Prize
ii. At the conclusion of the Wave One Play Period, every enrollment a Participant has that earned at least one (1) Point during the Wave One Play Period will be eligible for a Wave One Drawing ("Qualifying Enrollment").
iii. For each Qualifying Enrollment, the Participant will receive one (1) entry into the Wave One Drawing that corresponds with the maximum Point Streak associated with the Qualifying Enrollment, plus every other lesser number Point Streak drawing. (Example: If a Participant has two Qualifying Enrollments. One of those Qualifying Enrollments had a Point Streak of 4. The other had a Point Streak of 2. That Participant would have one entry in the Point Streak 4 Drawing, one entry in the Point Streak 3 Drawing, two entries in the Point Streak 2 Drawing, and two entries in the Point Streak 1 Drawing.)
b. Wave Two Drawings. On or about December 13, 2022, a total of 6,500 potential winners will be selected at random from among all eligible entries received, with the specific number of winners for each respective Point Streak Drawing within the series of Wave Two Drawings as specified in the Wave Two Prize Table in Rule 7.b., below. Odds of winning depend upon the number of eligible entries received for each drawing.
i. The Wave Two Drawings include the following Drawings:
(a) Wave Two 1 Point Streak Drawing for the Wave Two 1 Point Streak Prize
(b) Wave Two 2 Point Streak Drawing for the Wave Two 2 Point Streak Prize
(c) Wave Two 3 Point Streak Drawing for the Wave Two 3 Point Streak Prize
(d) Wave Two 4 Point Streak Drawing for the Wave Two 4 Point Streak Prize
(e) Wave Two 5 Point Streak Drawing for the Wave Two 5 Point Streak Prize
(f) Wave Two 6 Point Streak Drawing for the Wave Two 6 Point Streak Prize
