When will registration open?

Registration opens on March 29, 2024.

What is the cost of the conference?

What are the dates and times of the conference?

The event takes place Friday, October 4, 2024. The conference begins promptly at 8 a.m. and concludes at 4 p.m.

What payment forms are accepted?

All payments must be received by August 30, 2024. Any registration not paid in full by August 30, 2024 will be cancelled.

What if I cannot attend?

All refund requests must be submitted by email to events@momentousinstitute.org no later than August 30, 2024. Refunds cannot be issued by phone or by any other method.

Because refunds incur significant administrative time and processing fees, any refunds will be issued minus a \$25 processing fee.

All refunds will be processed after the conclusion of the event (minus the processing fee) using the same payment method used at the point of registration.

No refunds will be issued after August 30.

There is a \$25 processing fee to change attendees.
