Role: The Early Childhood Group Therapist role works with a team of other licensed mental health professionals to provide individual, family and group therapy to clients seeking services at Momentous Institute. The Early Childhood Group Therapist works with a team of professionals in the early childhood Launch Program, providing services for young children and their caregivers. In addition to group therapy, this clinician will also provide family and individual therapy. This clinician may also provide consultations with teachers at Momentous School, as needed. Services are provided on site at both Momentous Institute locations, Momentous School, as well as in community settings such as other local nonprofits or schools.

Responsibilities:

- Work as part of a multidisciplinary team including psychologists, licensed clinicians, parent educators and a social worker to ensure quality of care and services.
- Provide individual, family and group therapy to clients seeking services at Momentous Institute.
- When providing group therapy, attend planning meetings for these group programs.
- Provide consultations to support teachers at Momentous School as needed.
- If eligible (e.g. Licensed for at least 2 years or Supervisory status attached to license) provide supervision to trainees completing practicum or internship requirements for graduate degrees.
- Maintain and organize electronic clinical charts with current treatment plans, progress notes and other necessary documentation
- Provide consultation as needed to educators and other caregivers involved in clients' care
- Participate in program evaluation efforts within the organization
- Adhere to the legal and ethical requirements of the profession and the organization
- Perform other duties as assigned by Director of Group Programming

Qualifications:

- Texas licensed therapist; or licensed eligible (LPC, LCSW, LMFT)
- A minimum of three years' experience providing therapy with children and families
- 2 years' experience providing services to children 6 and younger

- Capacity to provide services at least two evenings a week
- Strong working knowledge of child development and evidence-based treatment approaches.
- Theoretical orientation that is strength based, and trauma informed
- Preference for candidates who have provided supervision to graduate trainees
- Fluency in both Spanish and English is preferred.
- Strategic thinker that supports program development
- Team oriented mindset
- Excellent communication skills verbal and written
- Excellent interpersonal skills
- Ability to receive feedback and open to self-reflection
- Ability to work with clients and colleagues of diverse ethnic and socioeconomic backgrounds.

Physical Demands:

- Occasionally moving self in different positions to accomplish tasks in various environments including tight and confined spaces.
- Constantly remaining in a stationary position, often standing, or sitting for prolonged periods.
- Occasionally adjusting or moving objects up to 15 pounds in all directions
- Occasionally operating motor vehicles
