Role:

We are seeking an experienced LPC or LMFT who is also passionate about children and families, training and supervising graduate students. This role requires provision of therapy and supervision in English and Spanish.

Responsibilities:

- Provide psychotherapy (individual, family, and/or group) and consultation services to children, adolescents and families in a multidisciplinary outpatient setting. - Supervise the clinical and administrative work of Momentous Institute's graduate level trainees. This includes supervision of trainees providing therapy in Spanish.

- Work in collaboration with Momentous School to support the needs of referred students, their families and teachers
- Participate in program evaluation efforts within the organization
- Maintain all paperwork requirements for both clinical and supervision services

Qualifications:

- Licensed to provide mental health services in Texas (LPC or LMFT). Candidates must be licensed for a minimum of 2 years.
- Supervision experience with graduate or post graduate students. Candidates with supervisor credentials preferred.
- Fluent in Spanish
- Able to work with clients/colleagues of diverse backgrounds including ethnicity, socioeconomic status, gender, religion, etc.
- Capacity to provide services at least two evenings a week
- Theoretical orientation that is strength based and trauma informed
- Strategic thinker that supports program development
- Team oriented mindset
- Excellent communication skills – verbal and written
- Excellent interpersonal skills
- Ability to receive feedback and open to self-reflection

Physical Demands:

- Occasionally moving self in different positions to accomplish tasks in various environments including tight and confined spaces.
- Constantly remaining in a stationary position, often standing, or sitting for prolonged periods.
- Occasionally adjusting or moving objects up to 15 pounds in all directions
