



## Clinical Group Therapist

**Reports to:** Huddle Up Manager and Director of Group Programming and Community Outreach

**Position Status:** Full- Time Exempt

Momentous Institute, founded by Salesmanship Club of Dallas in 1920, exists to build and repair social emotional health with children, families, and communities. Each year, we partner with over 5,500 children and family members through innovative education and therapeutic services. The organization also invests in research and training, including the annual *Changing the Odds* conference, to reach far more children than could ever be seen directly. Our mental health team is committed to offering services that are systemic, trauma-informed, and include brain and strengths-based perspectives. Services are offered on a sliding scale and no family is ever turned away for an inability to pay. Momentous Institute offers a truly dynamic work environment where therapy can unfold in collaboration with the family, without the need to bill or justify services to insurance companies.

### **Role:**

The Clinical Group Therapist works with a team of licensed mental health professionals in the Huddle Up Group Program, an experiential, multi-family, therapeutic program for pre-teens and teens (ages 10-15) and their families presenting with mental health concerns. This clinician will provide group, family, and individual therapy services as well as case management. Services are provided on site; at Momentous Institute, as well as in community settings such as local schools and outdoor camp settings.

### **Responsibilities:**

- Work as part of a multidisciplinary team including psychologists, social workers, and clinicians to ensure continuity and quality of care and services.
- Complete intake screenings for potential clients referred to the Huddle-Up program
- Provide after school, evening and summer programming for individuals, families, and groups.
- Provide group therapy to participants in Huddle Up programming at Momentous Institute and in the community
- Provide individual and/or family therapy to participants in Huddle-Up program, as well as clients seeking support through Therapeutic Services as needed.
- Provide casework to families participating in Huddle Up, including phone calls, parent consultations, referrals, and coordination of care.
- Maintain and organize electronic clinical charts with current treatment plans, progress notes and other necessary documentation.
- Provide consultation as needed to educators and other caregivers involved in clients' care.
- Initiate individual or team case consultation as needed.
- Participate in program evaluation efforts within the organization.
- Support and help create meaningful Salesmanship Club of Dallas involvement in the Huddle-Up Program activities.
- Exhibit Momentous Institute's core values: respectfulness, stewardship, innovation, collaboration, and hope.
- Adhere to the legal and ethical requirements of the profession and the organization.
- Attend overnight therapeutic camp a minimum of 3 times per year including weekends.
- Perform other duties as assigned by the program manager.

### **Qualifications:**

- Texas licensed therapist; or licensed eligible (LPC, LCSW, LMFT)
- A minimum of one years' experience working with children and families
- A minimum of one years' experience providing group therapy

- Capacity to provide services at least two evenings a week.
- Strong working knowledge of child development
- Theoretical orientation that is strength based and trauma informed
- Strategic thinker that supports program development
- Team oriented mindset
- Excellent communication skills – verbal and written
- Excellent interpersonal skills
- Ability to receive feedback and open to self-reflection
- Ability to work with clients and colleagues of diverse ethnic and socioeconomic backgrounds.
- Fluency in both Spanish would be a plus but not a requirement

**Physical Demands:**

- Occasionally ascending or descending ladders, stairs, scaffolding, ramps, poles and the like.
- Occasionally moving self in different positions to accomplish tasks in various environments including tight and confined spaces.
- Constantly remaining in a stationary position, often standing, or sitting for prolonged periods.
- Occasionally adjusting or moving objects up to 20 pounds in all directions
- Occasionally operating motor vehicles
- Occasionally assessing the accuracy, neatness and thoroughness of the work assigned.
