- Collaborate with local schools and community agencies to identify and recruit eligible parents/caregivers for parenting classes.

- Maintain and review class curricula to ensure it is up to date with emphasis on parent needs, cultural considerations, current literature, and research.

- Initiate individual or team consultation as needed.
