- Work in collaboration with Momentous School to support the needs of referred students, their families and teachers
- Participate in program evaluation efforts within the organization

- Licensed to provide mental health services in Texas (LPC, LMFT, LCSW)
- Minimum of three years of experience providing therapy
- Extensive training and use of somatic interventions with children and adults, particularly with clients who have experienced trauma.

- Fluent in Spanish and English preferred
- Able to work with clients/colleagues of diverse backgrounds including ethnicity, socioeconomic status, gender, religion, etc.
- Capacity to provide services at least two evenings a week
- Theoretical orientation that is strength based and trauma informed
- Strategic thinker that supports program development
- Team oriented mindset
- Excellent communication skills – verbal and written
- Excellent interpersonal skills
- Ability to receive feedback and open to self-reflection
